This Application Form and your cheque or bank draft must be received by **5.00pm (Sydney Time) on the Closing Date. Alternatively you can apply online at www.domacom.com.au and pay by BPAY, applications and payment must be received by <b>5.00 pm (Sydney Time) on the Closing Date.**
